#### **NEW BUSINESS:**

• April 20, 2016 will be the annual fair housing event: Information regarding event reviewed by Director Cummings.

- Director Cummings asked for permission to use funds from contracted services from the EEOC budget to run radio ads for housing and EEOC 4 different ones each for housing and employment. Housing ads would be the same ones that we ran before and employment ads would focus on pregnancy, LGBT, harassment and national origin. Commission approved use of funds for this purpose.

Director Cummings informed the Commission that she has asked them to work up proposals and submit them to her and Nikki and they would review them and see what could be done.

- Director Cummings indicated she is working on the annual report and will have a draft to the Commissioners by next week.
