## **LEGAL UPDATE/MATTERS:**

Four mediations were held in July, three were successful.

#### **NEW BUSINESS:**

- Ethel, who used to be our State and local coordinator through the EEOC has retired, also the Director has retired and there is no assistant Director. There is currently an interim Director at the EEOC, a gentleman from St. Louis.
- Director Cummings shared a report with the Commission which showed that Metro is the top performing FEPA for EEOC in the entire 5 state district.
- Director Cummings discussed the CDBG grant Metro has applied for. The general terms of the grant would be Metro conducting a fair amount of FH training to various city departments and contractors that do work with CDBG and the funds that Metro has ask for in the grant would be used for outreach for postcards and radio. It was mentioned by the board whether or not we use Spanish speaking radio stations. Director Cummings mentioned we have in the past but didn't recently due to a drastic increase in pricing. It was suggested that this be looked at again, so this

- will be mentioned to Liechty Media who does all the contract negotiations for this type of work for Metro.
- Metro recently completed their FHAP assessment with HUD and everything went smoothly. Although the final report has yet to come in, there should be no surprises and everything went well.
- There will be no more DH's on EO cases until Metro is notified as to whether or not we will receive an upward modification on our contract. Currently the average case age is 233 days.
