- **FHAP Assessment-** July 11th and 12th our federal monitor came in to make sure Metro was investigating our housing cases properly and operating in an appropriate manner based on federal guidelines. This assessment went very well and our monitor, Beverly Noble, gave us rave reviews and commended us for our organization, the quality of work we do, and the relationships we are making within the community.
- Community Development Partnership- Metro is continuing to meet with community development as we are planning our annual fair housing event. We have signed a Memorandum of Understanding with the City- Office of Housing and Neighborhood Services.
