OLD BUSINESS:

• Commissioner Tinnel would like to congratulate Commissioner Chambers on her election to City Council and thank her for her service on the Commission. Commissioner Keesling suggested we present her with a plaque and take it to Council.

CONCERNS FROM THE PUBLIC:

Keesling: Before our adjournment we have opened to the public, so do we have a public comment?

Steve: Yeah I'd love to comment in just a moment. Should I come closer or stay right here?

Wardlaw: You can come closer so we can hear you.

Steve: My name is Steve Gerber. I kind of got familiar with your office on a trial by fire I guess you would say. I was out at Yellowstone National Park this summer and I came back to Fort Wayne to find that I had missed a registered letter from Metro. As soon as I found out that I had one I tried to get my hands on it. I was able to do that and much to my chagrin I found out a tenant of mine had filed a complaint with the Commission. I've had duplexes in Allen County Fort Wayne.

Jenny: Just for a brief second, Chair Keesling because this is a public meeting open to the public this case that you're referencing is still ongoing and under investigation. If it's not public, then we can't speak about it on the record at this meeting.

Keesling: Right, so if you have any general comments you want to make you can do that, but specifics regarding your case, we cannot hear them.

Steve: My general concern here is that I have found the process to be very very adversarial, very adversarial. As somebody speaking in general terms I support what you are here to do, I really do, I'm for that all the way. So I find myself touching the fringes of what you're all about here. You got my concern. You got my cooperation, my intent to cooperation. But the process has been really really difficult for me as a citizen to navigate.

Keesling: I think what we should do would be if you can write out your issues and provide the Commissioners with something in writing as to what your concerns are.

Steve: Okay.

Keesling: That would be the appropriate method to move forward.

Steve: Okay, who should I address this to?

Keesling: Just the Metro Commissioners, there are seven of us.

Nikki: I think you can send it to our office and we can make sure it gets to the Commissioners.

Keesling: Right, if you send it here then they will make sure that we all see your letter.

Steve: Okay

Keesling: I think it should be addressed in writing is where it should go to.

Steve: I have no problems doing that I've just had really bad luck with getting responses, telephone responses, letter responses. I was told I'd get some things in writing and I've never gotten in writing. We've never even met. We've never even met face to face. I was not prepared to even speak to you today. I was coming to observe and try to learn what really is going on. How do you guys operate? Where do you get your guidelines from? So I can learn about it, so I can better comply. That's what I'm trying to see. So as I said this was not planned but when you turned to me and said do you have something you want to say, yeah I got something I want to say. I'm not getting really cooperation. I'm learning the hard way.

Keesling: So if you could put your concerns and your comments in writing and send it in, we would be happy to read it.

Steve: Should I address it to one person in particular?

Keesling: If you can address it to the full Commission.

Steve: I can do that, that's certainly not a problem. I try to be one of the good guys, I really do. **Keesling**: So if you address it to all of us, just to The Metro Commissioners, we would be

happy to read it and address it as we can.

Steve: Okay, that'll be great. I will do that, because I do want to address these issues.

Keesling: Okay, great. Thank you.

Steve: Thank you for your time.
